## TEFAF SHOWCASE 2020 APPLICATION

TEFAF looks forward to receiving your Showcase Application for TEFAF Maastricht 2020.

TEFAF Showcase gives recently established galleries the opportunity to participate in TEFAF Maastricht for one year and to gain experience of being part of an international fine art event.

TEFAF Showcase also introduces visitors to the Fair to some of the most interesting young emerging galleries from around the world.

### **I. Terms & Conditions of Showcase Application**

The following galleries can apply to participate in TEFAF Showcase that are:

- I. in the art trade business at the highest level
- II. included with the Chamber of Commerce as such not shorter than 3 years and no longer than 10 years

### **II. Applicable regulations**

By submitting this Showcase Application to TEFAF, the Applicant accepts the:

- TEFAF General Terms & Conditions of Application and Participation
- Selection Protocol
- Vetting Guidelines

as binding for the Showcase Applicant as well as for its company/employees and representatives.

For Showcase participants, the following exceptions apply to the TEFAF General Terms & Conditions of Application and Participation:

- the obligation re the non-recurring administrative costs as mentioned in Article 8 paragraph 1 does not apply.
- The possibility to modify the allocated stand as set forth in Article 10 paragraph 3 does not apply.
- The obligation to take out adequate third-party liability insurance as set forth in Article 14 paragraph 1 applies for an amount of at least EUR. 1,000,000.

Moreover, the Selection Protocol applies taking into account the conditions as set forth in Article I above.

### **III. Showcase Application deadline is by 15 September 2019.**

TEFAF must be in receipt of this Showcase Application by 15 September 2019.

Please note that Showcase Applications received after this deadline will not be considered by TEFAF.

### **IV. Correctness and completeness**

TEFAF expects that the Applicant informs TEFAF correctly and communicates all relevant information. Please note that if the Applicant fails to fulfill this obligation to fully inform TEFAF or if the Applicant provides TEFAF with false or misleading information at any time, TEFAF may not select the Applicant for the Fair or is entitled to terminate

the Participation Contract with immediate effect and/or take these circumstances into consideration in the selection for possible future Fair(s), if applicable.

The Applicant undertakes to inform TEFAF immediately of any change in the information contained in this Showcase Application and attachments and of any other information which may affect the assessment of admission of the Applicant by TEFAF.

It is the responsibility of the Applicant to ensure delivery of the Showcase Application and attachments to TEFAF. After receiving the Showcase Application, TEFAF will send an automatic confirmation of receipt. The Applicant can only prove it has submitted a Showcase Application, by showing this confirmation of receipt. As this confirmation of receipt is sent automatically, this confirmation of receipt does not prove that the Showcase Application was submitted in time or is complete and does not give the right to participate in the Fair.

#### **V. Admission to Showcase**

The number of Showcase Participants is limited to 5-6. Decisions about selection to the Showcase are made exclusively by the Showcase Selection Committee as per the Selection Protocol. Moreover, the Selection Protocol, the TEFAF General Terms & Conditions of Application and Participation, the current TEFAF Main Fair Showcase Application and the Vetting Guidelines as well as the relevant facts regarding the relevant Applicant are taken into account.

TEFAF is entitled at any time to request the Showcase Applicant to submit to TEFAF additional documentation and information (including but not limited to a certificate of good conduct or a comparable certificate, financial documents and official documents confirming that the Applicant has not been bankrupted). Failure of the Applicant to submit to TEFAF in a timely way such requested documentation and information may have negative consequences as to the selection of the Applicant.

#### **VI. Commitment to participate**

If TEFAF admits an Applicant to the fair, TEFAF will send the Applicant a Showcase Participation Contract signed by TEFAF, including information regarding stand allocation.

In submitting this Showcase Application, the Applicant commits itself to participate in the Fair and to sign the Participation Contract, in case the Applicant is admitted to the Fair.

Participants withdrawing after receiving a Participation Contract from TEFAF are liable to pay compensation for the work incurred, as set out in the TEFAF General Terms & Conditions of Application and Participation.

In case a Showcase Participation Contract is concluded, it is concluded for a definite period (a fixed term contract for one art fair as organized by TEFAF annually, therefore for one year) and can furthermore be immediately terminated under the conditions as set forth in the TEFAF General Terms & Conditions of Application and Participation.

#### **VII. Prior contract(s) and participation in the (Future) Fair(s)**

Neither TEFAF nor the Participant/Applicant is entitled to derive any right with regard to participation to Future Fair(s) from the Participation Contract and/or the Showcase Application, and/or any prior contract/agreement between TEFAF and the Participant/Applicant regarding Showcase Application or participation. The Participant/Applicant waives the right to invoke such possible rights.

### **VIII. Participation costs**

The costs of participation consist of stand costs and general costs, as specified below. All prices are exclusive of VAT and nonrefundable.

Unit Price : €8.500 per unit excluding VAT

TEFAF Showcase exhibitors will be assigned a unit of around 10.5 m<sup>2</sup>. This unit is of standard, ready-to-use format and includes power and lighting. Also included are 2 valid-for-one invitations for the Early Access day on Thursday and 4 invitations for the Preview on Friday valid for one person each, 20 regular fair invitations valid for one person each and 10 catalogues. Participating galleries will be listed in the catalogue in a special section entitled TEFAF Showcase.

Standard fittings for the TEFAF Showcase unit includes the following:

- Wall to wall carpeting (type Mambo);
- White painted wooden walls
- Your company name will be applied on a board which is vertically connected to your front;
- A stretched cheesecloth ceiling (white or off-white);
- Lighting: two tracks with each four halogen spots;
- Power: each unit is fitted with one Kilowatt electrical outlet. Use of electricity is included in the unit rental.

### **IX. Important dates**

- Showcase Application deadline: **15 September 2019**
- TEFAF informs the Applicants regarding the admission decisions: **Mid October 2019**
